Invitation for Bids for the Chepe Solar Lift Protection Work, Dhamilikuwa-01, Lamjung

1. The Government of Nepal has allocated funds towards the cost of **Water Resource Research and Development Centre (WRRDC)** and intends to apply part of the funds to cover eligible payments under the Contract for **Chepe Solar Lift Protection Work, Dhamilikuwa-01, Lamjung; Contract Identification No: WRRDC/CP/01/075-076**. Bidding is open to all eligible Nepalese Bidders.
2. Water Resource Research and Development Centre (WRRDC) invites sealed and electronic bids from all eligible bidders under National Competitive Bidding procedures for the following work:

A complete set of Bidding Documents may be purchased from the office **Water Resource Research and Development Centre (WRRDC), Pulchowk, Lalitpur** and **Ministry of Energy, Water Resource and Irrigation, Singhadurbar, Kathmandu** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **NRs 3000/-** (Rupees Three thousand only) till 2075/12/24.

Or

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO’s Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project’s Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. Sealed or electronic bids must be submitted to the office **Water Resource Research and Development Centre (WRRDC), Pulchowk, Lalitpur** by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before **12.00 hours (Noon) on 2075/12/25**. Bids received after this deadline will be rejected.
- Bidders, who choose to submit their bids electronically through e-procurement section of PPMO’s website www.bolpatra.gov.np/egp, may download the necessary parts of the bidding documents, prepare their Bids and submit their electronic Bids as specified in the Instruction to Bidders. Bids received after the deadline shall be rejected.

In addition to electronically submitted PDF files, the **Bidder shall be necessarily required to submit hard copy** of bid documents, original bid security letter and clarifications **within 7 days** from the date of Bid submission.

Non-submission of original printed hard copy of uploaded bidding document during e-bidding, original bid security letter and or clarifications by the Bidder within time as specified above shall affect the Bid as being non-responsive and Bid Security **shall be forfeited**.

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14.00 hours (Noon) on 2075/12/25** at the office of **Water Resource Research and Development Centre (WRRDC), Pulchowk, Lalitpur**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 1, 64,000.00 (One Lakh Sixty Four Thousand Only)**, which shall be valid for 120 days from the last date of submission of bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. The Employer reserves the right to accept or reject, wholly or partly, any or all the bids without assigning any reason, whatsoever.
